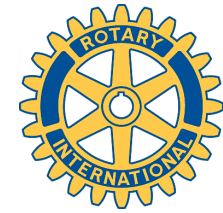

Service Above Self Membership Criteria

1. Person with good reputation in the community who has demonstrated a commitment to service and the Object of Rotary through personal involvement in local affairs; or
2. Adult of good character and good business and professional reputation, who holds or has held an executive position with discretionary authority in any worthy and recognized business or profession.
3. Must either live or work within the club's territory, or within the territorial limits of an immediately adjoining club.
4. Service minded person of good will.
5. Character and reputation above reproach.
6. Able to meet the financial and attendance obligations (50% attendance requirement) of Newark Rotary.

***Procedure for Proposing
a New Rotary Member***

1. Identify individual who appears to meet "Membership Criteria".
2. Invite prospect to attend one or more regular club meetings to become acquainted with other club members and ideals of Rotary.
3. Sponsor submits completed proposal form to Club secretary.
4. Membership Committee meets to consider application. If approved forwards to Board of Directors.
5. Board of Directors vote on approval. If approved, application is sent to Information Committee. Sponsor is notified of the candidate's acceptance. ***Until this time, the candidate should be unaware a formal membership proposal has been made.***
7. Information Committee meets with candidate and sponsor.
8. Candidate's name is published at 2 regular weekly Rotary and after 10 days from first publication, and payment of dues, is considered elected to membership.
9. The new member will be formally inducted at the next installation ceremony.
